On the above date and time dispatch received a call on 911 about a disturbance at 6137 15th Ct S. Back up units and I went to the address and met with Edith Carcamo who told us she lives here with her husband Prudencio. Edith told D/S Ramirez, #26677, in Spanish Prudencio has been yelling at her after an argument which started Thursday, Sep 16th. Since the argument, Edith states Prudencio has continued to yell at her and has been punching her with a closed fist multiple times around the upper part of both arms. Edith had bruising on the biceps and shoulders consistent with being punched. After telling D/S this verbally, she completed a hand written statement in Spanish which D/S Ramirez advised states the same. Edith declined to allow her bruises to be photographed.

Edith advised Prudencio was arrested for domestic battery a month ago. A review of PALMS shows it was on 8/9/21, PBSO case 21-094092.

Based on Edith's statements and injuries, probable cause exists for the arrest of Medina for violation of FSS 784.03.1a1, Domestic Battery.
