The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On the listed date and time and at the above location, officers responded to the American Social Restaurant located at 601 Harbour Island Bl S In regards to a large fight. Contact was made with the defendant who was obviously intoxicated as she was slurring her words, unsteady on her feet, and reeked of alcohol. The defendant was observed by numerous people hanging off the side of her boyfriend's car, attempting to get in while he was trying to leave to avoid conflict with her. The defendant also admitted to doing such. The defendant was screaming "bloody murder" (as described by witnesses) when attempting to enter her boyfriend's vehicle. One male observed the defendant fall to the ground and thought she got ran over. The male then ran to the defendant to render aid. The male approached the defendant's boyfriend and the both engaged in an affray. Because of the defendant's actions, multiple people placed calls to 9-1-1, her boyfriend's vehicle is damaged, and the male that attempted to intervene suffered a possible dislocated shoulder. The defendant's actions were captured on video and provided to officers on scene.

The defendant was positively identified via DHSMV photograph.
