On Monday March 14, 2022 at approximately 1807 hours, while in my Issued Palm Beach County Sheriff's Office uniform and in my Palm Beach County Sheriff's Office marked patrol vehicle, I was dispatched to 549 W. Kalmia Dr, Lake Park, Palm Beach County, Florida 33403 in reference to a simple domestic battery.

While at the incident location, contact was made with both parties Dale E. Simpson white male date of birth 10/06/1988 and Racheal J. Inman white female date of birth 05/02/1983. When contact was made with Simpson, he told me that he and his girlfriend Inman were in a heated argument after he learned that she had been in contact with her ex. Simpson said he told Inman that he was leaving. Simpson said Inman got mad because he was taking her sister's luggage to get his things out of apartment. Simpson said while he was bent over to get his things from the luggage to put them in a plastic bag, Inman punched him in the face which busted his right side upper lip.

It should be noted that Simpson had a swollen lip and a fresh cut.

While on scene, I also made contact with Inman who said that Simpson punch her in the face. Inman did have injury inside her upper lip but not consistent with someone being punched.

She was also verbally aggressive with EMS who responded to the scene after she requested their help.

I made contact with Simpson and Inman's roommate Gavin H. Patton white male date of birth 11/23/1991 who told me that Simpson was trying to leave but Inman kept following him. He also told me that it is normal for Inman to threat Simpson with arrest every time he tries to leave.

While at the hospital, Inman accused me and all deputies and EMS of setting her up. She even claimed that I saw her in a video and that's why she was being arrested. It should be noted that I did not see her in a video and I never seen or met Inman prior to this incident. She also claimed that the government was watching her.

Based on my investigation, probable cause exist for the arrest of Racheal J. Inman white female date of birth 05/02/1983 for domestic battery pursuant Florida State Statute 784.03(1)(1)
