Post-Miranda, the defendant admitted to consuming several alcoholic beverages prior to entering her vehicle and feeling the effects of the alcohol. The defendant was arrested on scene and transported to the Central Breath Testing (CBT) facility, where your affiant initially had to read the defendant her Implied Consent warnings. The defendant then elected to provide a lawful breath sample, and after a twenty (20) minute observation period, the defendant blew a .159% and .178% BAC sample.
