The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 The defendant was driving a silver Hyundai 4D bearing FI tag HKAG53. The vehicle was observed stopping past the stop bar and in the crosswalk at the intersection of Howard Av S / Cleveland St W. The vehicle then weaved in its lane as it continued northbound. The vehicle had a delayed reaction to the traffic signal at the intersection of Howard Av N / I275. The vehicle continued weaving in its lane and at one point drove with its passenger tires along the street parking lines. I was concerned that the driver was sick, injured, or impaired and conducted a traffic stop to check on their wellbeing. Upon contact with the defendant, she exhibited indicators of impairment to include bloodshot eyes, slurred speech, the odor of an alcoholic beverage emanating from her breath, poor spatial awareness, and admitted to having "1 drink". She later admitted to having "2 drinks". The defendant participated in HGN which showed 6/6 indicators, however refused to participate in remaining SFSE's. The defendant was subsequently arrested for DUI.

The defendant provided breath samples of .219/ .211.

The defendant was ID'ed via FL DL.
