The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a silver 2011 Infiniti G25X, 4 door, Ohio tag GUY3198. The defendant was stopped by TPD CPL T. Sims (46180) for nearly striking several parked cars due to driving too far to the right of the roadway, running onto and over a raised curb, weaving in the travel lane, and failing to stop for a properly posted stop sign. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed and her speech was slurred. The defendant was unsteady on her feet, and swayed while standing. The defendant stated that she had drank "too much to be driving", stated she drank several Bud Light tall beers, and that she was "drunk". The defendant agreed to perform Field Sobriety Exercises. The defendant had difficulty following simple instructions, and she exhibited signs and clues of impairment. The defendant was arrested for DUI. The defendant provided breath samples of .208% BrAC and .213% BrAC.

The defendant has a suspended Ohio DL (TD462027), as verified via a NLETS computer search in the State of Ohio. The defendant spontaneously stated that her OH DL was suspended due to a previous DUI. The defendant was positively identified by her OH DL.
