The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, at the above listed location, Deputy Kirk made contact with the defendant on a traffic stop after observing a silver Nissan Versa (FL:PGPN86) stopped in the roadway with no lights on. Upon Deputy Kirk's contact with the defendant she observed the defendant to have bloodshot, glassy eyes and detected the strong odor of an alcoholic beverage. Upon my contact with the defendant, indicators of impairment were observed to include dilated pupils, lethargic movements, disoriented, bloodshot, glassy eyes and agitated . The defendant refused the opportunity to perform Standardized Field Sobriety Exercises after being explained the consequences. The defendant provided two voluntary breath samples after a twenty minute observation period (.000/.000 BrAC). The defendant provided a lawful urine sample that is pending FDLE analysis. After being placed under arrest, the defendant attempted to pull away and tensed her body. The defendant then kicked my right leg with her foot. The strike was intentional and against my will. The defendant was identified by her Florida driver's license.
