The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 06/14/20, at approximately 0353 hours, affiant stopped defendant at the above scene for driving 64 mph in a posted 45 mph zone while weaving out of her lane over 2 feet to the right into a grass shoulder, and repeatedly to the left into adjacent lanes. Upon contact, the defendant was observed to have red watery eyes, slurred speech, and an odor of alcoholic beverage on her breath. Defendant was also observed to have a yellow paper wristband on her right wrist commonly used as nightclub admission. Defendant refused to answer simple questions, and required multiple lawful orders to exit her vehicle for affiants investigation. Outside of the vehicle the defendant refused to cooperate with affiant despite warnings and was arrested for DUI based upon the totality of affiants observations. The defendant refused to submit to testing after being read implied consent with a mobile intoxilyzer present and functional. In a search of defendant's property prior to transport, a bag of green leafy substance was found in her purse next to her wallet. When defendant was asked if she had a medical marijuana card, she spontaneously stated, "Its just a little weed. Can't I just get a citation for it, its less than 28 grams." The substance tested positive for THC using a field reagent test kit. The defendant was identified via her Florida drivers license.
