The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 On 09/16/2021 at approximately 0244 hours, contact was made with the defendant just south of the intersection of Suwannee Av N and Clifton St E reference TPD #21-394831. She was observed to be unsteady on her feet, had slurred speech, and had the strong odor of alcohol coming from her breath and person. She was observed to be seated in a gray 2011 Honda Civic with Florida tag 7251OZ initially, however, she was not in actual physical control of the vehicle (not running/unknown location of the keys). It was determined that law enforcement was not needed and cleared from the scene.

On 09/16/2021 at approximately 0255 hours, the same vehicle was observed traveling westbound on Idlewild Av E towards Florida Av N with its high beams on and the driver/defendant was observed to be the same person who law enforcement had previous contact with. A traffic stop was conducted reference the traffic infraction and reasonable suspicion that the driver was intoxicated. Contact was made with the driver/defendant who was observed to have glassy/bloodshot eyes, slurred speech, highly verbally combative, and was unsteady on her feet. Additional clues of impairment were observed during SFSTs and the defendant was arrested for DUI.

The defendant was transported to Central Breath Test where after being read Implied Consent, she declined to submit to testing. She was positively identified via DHSMV photograph.
