The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On listed date, time, and location, I responded to a vehicle collision. Upon my arrival, I observed the subject still behind the wheel of her vehicle. An on-scene road ranger advised that he was on-scene approximately 3 minutes prior to my arrival and also observed the subject behind the wheel of her vehicle. The subject was determined to be the at-fault driver in the vehicle collision. The other driver involved in the collision stated that she observed the subject swerving erratically behind her vehicle prior to the collision. While speaking with the subject, I observed her to display several signs of possible impairment (slurred speech, bloodshot watery eyes, odor of alcohol on breath, inconsistent statements, confused regarding what happened and her location.) After changing hats, I read the subject her Miranda Rights and the subject invoked her rights. The subject was transported off the interstate for SFSEs (HGN, MRB, and FTN.) The subject performed poorly and was placed under arrest for DUI. The subject was transported to HCSO's Orient Road jail and provided two valid breath samples of 0.188 and 0.190.
