The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 01 day of DECEMBER, 2019,

at approximately 5:17 PM, at 6321 113TH ST N, APT 1105, SEMINOLE, FL, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE DEVAN CORTEZ, HER DAUGHTER AGAINST THE WILL OF DEVAN CORTEZ TO-WIT: DEFENDANT PUSHED DEVAN, CAUSING HER TO BE PUSHED BACKWARDS.

I WAS DISPATCHED TO A DOMESTIC VIOLENCE CALL AT THE ABOVE ADDRESS BY DEVAN CORTEZ. UPON ARRIVAL DEVAN SAID SHE WAS AT THIS ADDRESS CHECKING ON HER MOTHER, THE DEFENDANT. DEVAN MADE CONTACT WITH THE DEFENDANT'S EX-HUSBAND, STEFAN KORTS. DEVAN ASKED STEFAN IF THE DEFENDANT WAS OKAY, AND HE SAID SHE HAS BEEN ABUSING ALCOHOL AND DRUGS, POSSIBLY METHAMPHETAMINE AND HEROIN.

GIVEN PERMISSION FROM STEFAN, DEVAN ENTERED THE RESIDENCE TO SPEAK WITH THE DEFENDANT. ONCE DEVAN ENTERED THE RESIDENCE AND THE DEFENDANT SAW HER, THEY GOT INTO A VERBAL ALTERCATION. THE DEFENDANT BEGAN YELLING AT DEVAN, AND EVENTUALLY PUSHED DEVAN AGAINST THE WALL, MAKING A PICTURE FRAME FALL DOWN. AT THAT POINT, DEVAN LEFT THE RESIDENCE AND CALLED LAW ENFORCEMENT, BECAUSE SHE WAS CONCERNED OF THE DEFENDANT'S SUBSTANCE ABUSE.

I ALSO SPOKE WITH STEFAN, WHO PROVIDED A SIMILAR STATEMENT. THE DEFENDANT SAID LAW ENFORCEMENT HAD NO BUSINESS ASKING HER ABOUT THE INCIDENT, AND WANTED LAW ENFORCEMENT GONE. THE DEFENDANT WAS PLACED IN HANDCUFFS, SEARCHED FOR CONTRABAND, AND PLACED IN THE BACK OF MY PATROL VEHICLE. LATER, THE DEFENDANT BEGAN COMPLAINING OF SHORTNESS OF BREATH, WHERE THE FIRE DEPARTMENT WAS CALLED, AND TREATED THE DEFENDANT. THE FIRE DEPARTMENT SAID THE DEFENDANT HAD NORMAL SIGNS. THE DEFENDANT WAS TRANSFERRED TO PRISONER TRANSPORT WITHOUT FURTHER INCIDENT.

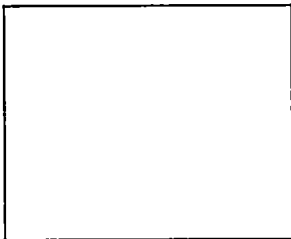
