The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

On 08/23/2020, at approximately 0016 hours, at the intersection of James L Redman Pw and 60 Hw W , Deputy Hall #235455 contacted the defendant on a traffic crash he was dispatched located at the above intersection (see HCSO 20-541617). Upon arrival, Deputy Hall observed the defendant behind the wheel of a gold Acura bearing FL tag NCXU46. The total estimated property damage was valued at \$5000. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and admitted to drinking two beers prior to the crash post Miranda. Standardized Field Sobriety Exercises were refused. The defendant was advised the Standardized Field Sobriety Exercises were voluntary, could be held in a criminal proceeding, and I would have to base my decision on the totality of the investigation. The defendant continued to refuse. Based on the totality of the investigation, the defendant was arrested for DUI and refused two lawful breath samples. I advised the defendant of the Implied Consent Warnings in Central Breath Testing room CB-02 where the defendant still refused (see video). The defendant was positively identified via a Florida DL.
