The defendant was observed driving eastbound on I275 from the Howard Av exit area. I observed the vehicle leave the left turn signal on for an extended period of time before changing lanes to the right. I observed the vehicle weave in its lane and several times the drivers side tires touched the lane line. I suspected the driver to be sick, injured, or impaired and conducted a traffic stop on the vehicle. I made contact with the defendant and observed his eyes to be glassy. I asked the defendant to step out of the vehicle and observed him to lean on the truck for balance. I could smell the odor of an alcoholic beverage emanating from his breath. I asked the defendant if he would participate in SFSE's and he agreed to participate in HGN. The defendant refused to participate in remaining SFSE's and was subsequently placed under arrest.

The defendant refused to provide a breath sample after being read Implied Consent.

The defendant was ID'ed via FL DL.
