	DS [REDACTED] was one of the 'decoys' posing as a prostitute at 18th Ave N & N Dixie Hwy in the City of Lake Worth Beach FL. DS [REDACTED] was approached by Rafael Astorga Abrego DOB 01/27/58 who was driving a gray Toyota bearing FL tag Z916JK.									
	Upon the defendant's contact with the deputy, a conversation ensued. During the conversation, Astorga stated to [REDACTED] that he would pay \$100 for 3 hours of sex. Astorga was directed by DS [REDACTED] a meeting spot.									
	The predetermined signal was given where the arrest team responded from a concealed location. Deputies stopped Astorga and took him into custody without incident. Astorga was placed in handcuffs that were checked for fit and double locked. Astorga was transported to the District 14 substation for processing and then transported to the Palm Beach County Jail.									
	Defendant requested his vehicle be parked in the 1100 block of 17th Ave N where it was properly parked and secured.									
	The audio/video of the transaction was packaged and entered into evidence at the D-14 Sub Station.									
	Based on the above facts listed above probable cause exists for the arrest of the Rafael Astorga Abrego for SOLICITING ANOTHER TO COMMIT PROSTITUTION per F.S.S 796.07 (2)(F).
