The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On May 8, 2020, at approximately 0649 hours, Deputy C. Hoffman arrived in the parking lot of 6405 Hillsborough Av. W., in reference to a person down call for service. The comments of the call advised a male was passed out inside of a vehicle. Deputy Hoffman observed the defendant asleep in the driver's seat with the vehicle running. The vehicle involved is a black in color, four door, Range Rover, bearing FL tag PB5SZ. Deputy Hoffman placed the vehicle from driver to park, turned the vehicle off, and woke the defendant. The affiant responded to the scene and detected multiple signs of impairment. Due to the signs of impairment, the affiant requested the defendant perform the SFSE's, which the defendant agreed to perform. The defendant continued to show signs of impairment and was subsequently arrested for DUI. Upon arrival to CBT, the defendant provided two lawful sample of his BrAC, which yielded two results of 0.000. The results of the defendants BrAC results did not match his level of impairment, at which time I requested he provide a urine sample. The defendant provided a urine sample which was later sent to FDLE for testing. The defendant was provided with one DUI citation (#A3ONARE), which reflects the charge. The defendant was positively identified via his FL DL.
