
On 06/17/21, at approximately 1757 hours, I responded to 5700 W Glades Rd (Macys parking lot), in reference to a battery.

BRPD dispatch advised that the caller and victim, W/M Steven Britton, told them that a vehicle had followed him from W Glades Rd and that the driver of that vehicle "beat him up".

Upon arrival, Officer Phillips had made contact with both Britton and the offender, W/M Ramez Abla. I observed both Britton and Abla to be injured from some sort of altercation and both were bleeding.

I made contact with Abla who was sitting next to his vehicle, black Toyota Corolla bearing FL tag# CHYR71. I began fact finding and asked Abla what was going on. Abla advised that he was driving westbound on W Glades Rd to get onto I 95. Abla advised that a vehicle in front of him, Britton's vehicle, began "brake checking" him. Abla advised the vehicle was a Blue Toyota Camry bearing FL# ASKA78. Abla stated that he went around Britton's vehicle to continue onto I 95, but Britton followed him and pulled up next to him at the stop light at 1000 W Glades Rd. Abla stated that Britton called him a "Spick Nigger" and Britton said he was going to shoot him. Abla stated that he saw Britton rummaging around his center console, but never saw a gun. Abla said that Britton continued to drive next to him shouting curse words and derogatory words at him. Abla state that he drove past I 95 where he was supposed to get on the interchange. Abla stated that once they got to the flashing lights just west of Butts Rd on W Glades Rd and Britton quickly made the U-turn to go back east bound on W Glades Rd. Abla said he continued driving westbound until he got to traffic light at the entrance of the Town Center Mall. Abla said he then went back eastbound to go back to I 95. Abla said when he

<p>got to the light at Butts Rd and W Glades Rd, he saw Britton in the right turn lane to go Southbound on Butts Rd. Abla said he was in the center lane. Abla said that Britton again began yelling at him and said "let`s go mother fucker". Abla said that he thought Britton had a gun, due to the fact that Britton said he would shoot him and that Britton was reaching around inside the vehicle. Abla said he was in fear for his life from what Britton might do. Abla went on to say that if he`s going to get shot he wants to face it head on. Abla said he then followed Britton into Macys to confront him and get his information to call police after the fact. I asked why Abla followed Britton if he was afraid for his life and he could not provide an answer. Abla said that he pulled behind Britton in the Macy`s parking lot. Abla said both cars stopped and he and Britton both exited the vehicles. Abla said that Britton began walking toward him aggressively and Abla struck him in the face. Abla said they got into a scuffle and bystanders broke up the fight. Abla said that is when police arrived. I observed scratches and abrasions to Abla`s right temple and neck. Abla also complained of pain in his left knee. FD examined Abla`s injuries on scene.</p> <p>I then spoke to Britton who advise that he was driving westbound on W Glades Rd in front of FAU (about 1000 W Glades), when a vehicle began driving erratically behind him. Britton said that the vehicle which he identified as Abla`s vehicle was swerving in and out of lanes trying to cut him off. Britton said they exchanged curse words and words of animosity at each other while driving. Britton said he continued driving westbound on W Glades Rd to get away from Abla, but Abla continued to follow him. Britton stated that as they approached the flashing lights just west of Butts Rd., he made a sharp Uturn to get away from Abla. Britton said that Abla continued westbound and Britton thought that was the end of the situation. Britton said he drives for Uber, so he was going to park in the Shanes Rib Shack parking lot at 2240 NW 19th St to wait for a ride. Britton said that he was waiting to turn right to go southbound on Butts Rd, when Abla pulled up beside him and continued to scream and yell. Britton said they exchanged words again and Britton made the right turn to go south onto Butts Rd. Britton stated that he was in the left turn lanes on Butts Rd to make the turn on to NW 19th St, when Abla drove onto the driver side of his vehicle and into opposing lanes. Britton said that is when he decided to drive into the Macys parking lot to get away from Abla. Britton said that he thought if he was around other people, that Abla would stop following him. Britton said that is when he stopped in the parking lot. He saw that Abla had followed him and stopped behind him. Britton stated that he got out and before he could call 911, Abla aggressively walked up to him and they were yelling at each other. Britton said that Abla punched him in the face and they began to fight and scuffle on the ground. Britton said that he thought other people were trying to jump him too, but they pulled Britton and Abla off of each other. Britton said he made the call to police and police arrived shortly thereafter. I observed scratches and abrasions and blood to Britton`s face. Britton`s lip was also split. BRFD advised that Britton would need stitches.</p> <p>I then spoke with a witness, B/F Veloundre Petitval. Petitval advised that she got out</p>
