Upon contact with the defendant, he exhibited indicators of impairment to include a green bar bracelet on his right wrist, poor dexterity in attempting to retrieve his ID, the odor of an alcoholic beverage emanating from his breath, droopy eyes that were bloodshot and glassy, unsteadiness on his feet, slurred speech, and admission of drinking.
