On the above date, time, and location, I was stopped for the red traffic signal in the outside lane on US Highway 301 northbound at State Road 60, when the I observed a silver Mercedes passenger car stopped ahead of me. A female subject stopped for traffic in the inside lane informed me the driver of the aforementioned Mercedes was asleep. I exited my patrol vehicle and approached it on its driver side. Prior to making contact with the driver, he woke up and accelerated through the intersection. The driver continued at a slow rate of speed on US Highway 301 northbound, applying its brakes intermittently. I activated my emergency lights and conducted a traffic stop on the vehicle. Once stopped I approached the vehicle on its driver side and made contact with the driver, who was later identified as Randell Jay Sehres (Defendant), via the Florida Driver's License he provided. I observed the defendant's speech was slurred and raspy, and he moved in a slow and lethargic manner. I observed several loose aluminum cartridges throughout the entire vehicle. The defendant advised he wasn't taking medication, but he inhales nitrous oxide. The defendant agreed to and performed poorly on Standardized field Sobriety Exercises and was subsequently placed under arrest for DUI.
