The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11-12-2020, at approximately 0900 hours, at 2213 Lone Palm Dr, the defendant and the victim were engaged in a verbal altercation regarding marital dealings. The defendant struck the victim in the face, causing bruising and redness over her left eye, redness and swelling near her right temple, and bruising underneath both eyes. The victim also had purple bruising on her right wrist. The bruises were deep purple in color and had redness around them that slightly faded throughout your affiant's time at scene, which was approximately one hour. The strikes were done against the victim's will, and the victim stated she was in fear for her life multiple times through your affiant's time at scene. The defendant and the victim have been married for approximately 20 years, live together as a family, and have children in common. The defendant, post-Miranda, denied the offense. The victim identified the defendant as the person who committed the offense; the defendant was positively identified by DHSMV photograph and Florida driver's license.
