 On 08/01/2020, at approximately 2122 hours, I responded to 1201 Orient Rd. Tampa, FL. 33619(Orient Road Jail), to assist Deputy Copeland(ABN:244823) with a domestic violence-battery case(20-495939). Deputy Copeland informed me that the defendant returned to the incident scene in a Dodge Pick-up truck(3697YB/VIN:1D7HA18D24S740470). Deputy Copeland observed the defendant driving the vehicle. Deputy Copeland observed indicators of impairment from the defendant. Due to the defendant having battery charges, he was transported to Central Breath Testing by Deputy Riendeau(ABN:256737). There I explained to the defendant that the domestic violence-battery case was ended and a driving under the influence investigation was beginning. The defendant understood. I observed the defendant to have blood shot eyes and the odor of an alcoholic beverage emitting from his breath. The defendant elected to perform the standardized field sobriety exercises, and doing so, I observed more indicators of impairment. The defendant refused to provide lawful breath samples after implied consent was read. The defendant identified himself via Florida driver's license.
