Probable Cause Affidavit

Before me this date personally appeared SANTOS, MARIA P (3729) who being first duly sworn deposes and says that on 16 day of April, (year) 2017 at 5990 NW 15TH ST, SUNRISE, FL 33313 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

I made contact with the defendant (Post Miranda) who stated that he pushed [REDACTED] because he did not listen to him when he asked him to pick up his mother. The defendant admitted that he pushed Satchin, ripped his shirt, and broke his glasses by smashing them on the ground. I could smell an odor of alcohol on the defendant, and asked if he had been drinking today. The defendant stated that "Yes, I drank 2 beers and a shot of vodka".

The defendant was charged with Domestic Battery FSS 784 03-1A1. The defendant was placed under arrest and transported to BSO Main Jail.
