The undersigned swears there are reasonable grounds to believe that the above-named defendant in Hillsborough County, Florida, did . On 10/01/2021, at approximately 2335 hours at 1206 Memory Lane, Lutz, FL 33549, the defendant and victim engaged in a verbal altercation about a song on a phone. The altercation became physical when the victim threw items off the table that hit the defendant in the face. The defendant then followed the victim into the house, waited for her to get out of the restroom, and grabbed her by the neck intentionally and against the victim's will, impeding the victim's normal breathing and circulation of blood. The victim did not lose consciousness during the altercation. The defendant then grabbed the victim and threw her out the front door of the residence, locking the door behind her. The victim and defendant are married and reside together as a family. The defendant was still on the scene and identified himself as the defendant.
