The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 09/17/2021, at approximately 00:48 hours, I responded to a disturbance where a female was calling advising there was an issue at this residence but would not explain the situation to Temple Terrace Dispatch. I responded to 228 Willowick Ave. Upon my arrival, I noticed a female crying and walking away from my patrol vehicle. I made contact with the female, at first the female was uncooperative and not unwilling to speak to the police. After speaking to the female, she started to calm down and advised her name was Rebecca Holland, 09/26/1992. DEF Rebecca Holland stated she and her husband (Wade Holland) had an altercation. DEF Rebecca Holland advised her husband was intoxicated and was attempted to drive to the gas station for more alcohol. When VIC Wade Holland got into the vehicle, DEF Rebecca Holland grabbed VIC Wade Holland and bit down on him, causing him to bleed. I spoke with VIC Wade Holland. VIC Wade Holland advised while he was attempting to get into his vehicle, his wife DEF Rebecca Holland bit him for trying to drive intoxicated. VIC Wade Holland advised after he was bit, they went back inside and separated. While separated, VIC Wade Holland went to DEF Rebecca Holland's room to check on her, that is when another incident occurred. DEF Rebecca Holland jumped on the back of VIC Wade Holland, while DEF Rebecca Holland was on VIC Wade Holland's back, she bit him in the ear, causing him to bleed again. After concluding my investigation, I came to the conclusion that DEF Rebecca Holland was the primary aggressor since she bit Wade Holland several times causing him to bleed.
