On Wednesday, March 2, 2022, at approximately 0940 hours, I responded to Florida Atlantic University's Football stadium (bldg. 100), room 118 at the Florida Atlantic University, in response to a property damage. Bldg. 100 is in the jurisdiction limits of Florida Atlantic University, 777 Glades Road, Boca Raton, Florida, 33431, within Palm Beach County, Florida.

Upon arrival, I made contact with Russell Philipp, who was

identified by his Florida driver's license. Philipp is reporting that an FAU-owned utility vehicle and fence were found damaged.

Phillips advised that this morning at 0641 hours, he received a text from one of the athletic trainers that a Toro workman 3100 utility vehicle (T780) (serial number 07363-270000716) was found outside of gate 7 in the bushes. The vehicle was damaged and was considered inoperable.

Philipp stated that upon receiving the text message and pictures, he noticed that the tires were facing the opposite direction and that the steering column was broken.

When Philipp arrived on the scene, he stated that the fence was also heavily damaged.

Philips stated that the steering column located under the damaged vehicle is estimated to be about USD 3,000. He also estimated the damage to the gate to cost approximately USD 2,000.

Latents were attempted to be taken but could not due to staff moving the vehicle when it was located.

Video footage camera B-0100-FS-Circle Gate Staircase at 03:21:10 AM, I observed a white female and a white male operating the utility vehicle. The white female had brown hair, a black top, a brown sweater, gray sweatpants with "Hollister," and white shoes. The white male had long black hair with a white and black baseball cap, a black hooded sweater, gray shorts, and black and white shoes. The white female was in the driver's seat, and the white male was in the passenger seat. The two individuals were holding up their phones towards the road, with a flash illuminating from the camera.

On camera B-100-FS-Circle Gate at 03:23:07 AM, the utility vehicle comes to a rest, and the white male gets out and runs out of the view of the camera. The female sits in the utility vehicle while on her phone and waits. At 03:24:15 AM, the white male returns and gets into the utility vehicle passenger seat.

On camera B-0100-FS-Circle Gate West Concourse at 03:24:57 AM, the two individuals are seen riding in the utility vehicle going southbound through the corridor. At 03:25:08 AM, the white male seemingly points to the gate, and the white female goes in that direction.

On camera B-0100-FS-Gate 7 West Corridor South View at 03:25:08 AM, the white female drives the utility vehicle attempts to navigate through the open gate but hits it. After failing to make it through, the utility vehicle was no longer operable. The two individuals get out of the utility vehicle and observe the scene.

The two individuals then see a golf cart nearby, and the white male attempts to start the golf cart. The white male presses the breaks several times and appears to be trying to start the ignition. After several failed attempts to start the golf cart, the two individuals attempt to start another one.

The white male attempts to steal another golf cart on camera B-0100-FS-Gate 7 West Corridor North View at 03:28:46 AM. The white male attempts to place an unknown object in the ignition and put his foot on the break. The white female walks over to the passenger side. The male was unsuccessful, and both individuals left the scene.

Based on their clothing descriptions, the individuals were spotted entering the west entrance of Parliament Hall (Bldg. 102). It should be noted that entry through this door requires an FAU Owl Card swipe, which is recorded.

The two individuals were wearing the same clothing from the incident earlier in the day. The card reader revealed Reece Seyler swiped at 09:46:58 PM at the 102 PAR Main entrance west door that evening.

FAU Communications advised Reece Seyler is an FAU resident student who resides in bldg. 102 room 405L1.

On Thursday, March 3, 2022, at 0830 hours, I went to bldg. 102 to make contact with Seyler. I knocked on room 405, and a white female greeted me. The white female fit the description of the individual I saw on video footage. I stated that I was here to see Reece Seyler and she stated that it was she who I was speaking to. Immediately after identifying herself, Reece asked if she was going with myself and Officer Godinez (W459). I replied, "Yes." The name Reece Seyler was given in the confession of Trevor Loughlin (Codefendant), who was the white male seen in the video with Seyler. Seyler was identified by her Florida Driver's license.

While in the vehicle, Seyler asked how Tyler Loughlin was. I replied, "He is fine." Finally, I informed her that I was investigating a grand theft of a golf cart.

Seyler was transported to the Florida Atlantic University Police Department's interview room.

I read Seyler her constitutional rights from a preprinted agency-issued Miranda Warning card. Seyler completed and signed
