The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

The defendant was operating a gray 2020 Nissan Sentra, 4 door, Florida EYKS93. The defendant failed to stop for a steady red traffic light, and when he made a left turn after running this light he accelerated so quickly that the vehicle rear end to slide side to side. The defendant accelerated to a high rate of speed, which was visually estimated and patrol car paced at speeds in excess of 60 MPH in a properly posted 45 MPH speed limit and speeds in excess of 85 MPH in a properly posted 50 MPH speed limit. The defendant's vehicle was weaving in the travel lane, and the tires crossed onto and over painted lane markers several times. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant's face was flushed, his speech was slurred, and he had a drunken/dazed look about his face. The defendant displayed cognitive issues as he had difficulty remembering what documents had been requested. The defendant stated he had consumed several alcoholic beverages (margaritas) tonight. The defendant was unsteady exiting the vehicle, and he swayed noticeably while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and based on a totality of the circumstances he was arrested for DUI. The defendant provided breath samples of .180% BrAC and .178% BrAC. The defendant made spontaneous statements that he "had a lot to drink at the club" and that he knew he was "drunk". The defendant was positively identified by his Florida DL.
