I CONDUCTED A TRAFFIC STOP AND MADE CONTACT WITH THE DEFENDENT WHO WAS THE SOLE OCCUPANT OF THE VEHICLE. UPON APPROACH I SMELLED THE ODOR OF ALCOHOLIC BEVERAGE EMITTING FROM THE VEHICLE. ONCE THE DEFENDENT STEPPED OUT OF THE VEHICLE I CONTINUED TO DETECT THE ODOR OF ALCOHOLIC BEVERAGE ON THE DEFENDENT'S BREATH. THE DEFENDENT VERBALLY AGREED TO PERFORM SFSTS. ON HGN I OBSERVED ALL 6 CLUES OF IMPAIRMENT. ON THE WALK AND TURN I OBSERVED 3 CLUES OF IMPAIRMENT. ON THE ONE LEG STAND I OBSERVED 2 CLUES OF IMPAIRMENT.

POST MIRANDA THE DEFENDENT STATED HE HAD ONE BEER (16 OZ IPA) AT A BAR ABOUT 30 MINUTES PRIOR TO THE TRAFFIC STOP. A WITNESS FROM THE BAR ARRIVED ON SCENE AND STATED HE OBSERVED THE DEFENDENT CONSUME A MOSCOW MULE (1.5 OZ VODKA) AS WELL AS 1.5 OZ OF TEQUILLA PRIOR TO THE DEFENDENT LEAVING THE BAR.

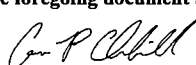

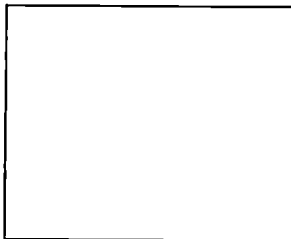
