	<p>On 07/14/2021, at approximately 18:50 hours, I was dispatched to the Publix located at 4849 S Military Trail, Greenacres, in reference to a report of a delayed battery to a pregnant female. Upon arrival I made contact with Victim B/F Lucile Cindy Cadet 11/04/1989 who advised the following.</p> <p>Cadet stated that while at the checkout lane she got into a verbal argument with a female later identified as Renee Helene Davis 02/15/1972 over having too many items in her shopping cart. Cadet stated that she advised Davis that she was pregnant as they continued to argue. Cadet then stated that Davis walked towards her direction and pushed the shopping cart into her stomach. Davis paid for his items and walked out of the store. It should be noted that Cadet is 35 weeks pregnant and showing.</p> <p>I made contact with the cashier who witnessed the incident B/M Ivebens Eliacin 04/11/2002 who stated that he observed as Cadet and Davis were in a verbal argument and he heard Davis cursing at Cadet. Eliacin stated that in the middle of the argument he heard was Cadet stated she was pregnant and Davis responding that she did not have to respect her because she was pregnant. Eliacin then stated that he observed as Davis struck Cadet with the shopping cart onto her stomach.</p> <p>Contact was made with the Publix Assistant Manager W/M Joshua Rongione 09/04/1989 who was able to show me the video surveillance of the store and where I observed as Davis and Cadet are involved in a verbal argument. On the surveillance it is observed when Davis strikes Cadet with the shopping cart.</p> <p>The security guard at the Publix B/M Desimoll Destine 03/27/1975 was flagged down reference the incident and was able to get the license plate from Davis vehicle as she was leaving the parking lot. Destine provided me with the information which assisted in locating Davis.</p>

Davis stated that she was advised by Cadet that she was pregnant after she went in front of her in line. Davis stated that she pushed the cart into Cadet because she was being threatened. Davis lastly stated that she might of pushed the cart but she did not mean to do it.</p> <p>Video surveillance was submitted into an evidence locker at District 16.</p> <p>Based on my investigation on scene, to include victim and, witness statements, probable cause exists at this time to charge W/F Renee Helene Davis 02/15/1972 with the following: Felony Battery pursuant to FSS 784.041(1).</p>
