The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a gray 2008 Hummer H3 (FL TAG #LFKA08) westbound on Hillsborough Av W, following very closely behind another vehicle with his bright lights activated and weaving back and forth in and out of his lane (road raging because he believed the other vehicle cut him off). During the traffic stop, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, droopy eyelids, heavily slurred speech, poor balance, lethargic/sluggish appearance, admitted to drinking "2 bud light beers" and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent and refused to provide a breath sample.
