<p>On 07/19/2020 myself and DS Rodee (9707) responded to 1706 Allison Dr, West Palm Beach, FL, 33409 in reference to a delayed hit and run. I met with victims, Evarista Francisco and Juan Morales, who stated that their vehicles were struck at some point of the night.</p> <p>Evarista's vehicle is a white 2019 Toyota Corolla bearing FL tag HEAT92 and Juan's vehicle is a red 2012 Toyota Sienna bearing FL tag 319RZD. Both vehicles had extensive damage. Evarista's vehicle was struck in the rear end, causing it to hit the rear of Juan's vehicle. As the suspect vehicle was trying to leave the scene, it also struck a tree in Evarista's yard and left fresh tire tracks in the mud on the northwest side of the residence. The tire tracks led directly from the vehicle to the damaged tree.</p> <p>Based on the pieces of headlight and front turn signal left at the scene, it was determined that the suspect vehicle was an older model Ford F150 with front end damage. The area was checked for a vehicle matching that description, which was located at 1920 Lakeshore Dr, West Palm Beach, FL, 33409 (same neighborhood as victim).</p> <p>The vehicle was a green 1997 Ford F150 bearing FL tag Y00XTJ, with matching front end damage. The damage to the truck was a missing/broken front passenger headlight and turn signal, dented bumper with pieces of the tree (matching Evarista's tree) still connected to it, and wet mud from the victim's yard still on the bottom of the truck.</p> <p>Contact was then made with a male who identified himself as Ricardo Ortiz (06/26/1999) via his Mexican ID Card. He stated that he was the driver of the vehicle at the time of the incident. He also admitted that he did not have insurance or a valid license.</p> <p>Based on the above facts, it is determined that Ricardo Ortiz did operate a vehicle on a public roadway without a valid driver's license, in accordance with FSS 322.03(1). During that time, Ricardo collided with multiple vehicles and a tree, causing property damage estimated at approximately \$7000, in accordance with FSS 316.061(1).</p>
