Upon stopping the vessel, affiant made contact with the operator / defendant. During personal contact with the defendant, affiant observed him to have blood shot watery eyes, an odor of an alcoholic beverage coming from his breath and observed him to be unsteady as he moved around the vessel. Based on this, affiant requested the defendant perform seated standardized field sobriety tasks. The defendant refused to perform the task. The defendant was arrested for boating under the influence. The defendant was advised Florida Implied Consent. The defendant stated he understood and refused to provide a breath sample. The defendant was transported to CBT and again refused to provide a breath sample. The defendant was booked into the Orient Road Jail without incident. The defendant verbally identified himself and produced a Florida drivers license.
