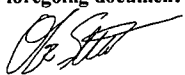

CONCERNED FOR THE WELFARE OF THE SUBJECT I CONDUCTED A TRAFFIC STOP ON THE VEHICLE TO DETERMINE IF THE DEFENDANT WAS SICK, INJURED, OR IMPAIRED. UPON MAKING CONTACT WITH THE DEFENDANT I OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE THAT THE DEFENDANT'S EYES WERE BLOOD SHOT, Watery, AND Glossy. I COULD SMELL THE STRONG AND DISTINCT ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS MOUTH THAT WOULD GROW STRONGER WHEN HE SPOKE. HE WAS ALSO WEARING A WRIST BAND FROM A LOCAL BAR. THE DEFENDANT DENIED ANY ALCOHOL CONSUMPTION AT ALL BUT DID CONDUCT SFE'S IN WHICH HE DISPLAYED SEVERAL MORE SIGNS OF IMPAIRMENT AND WAS UNABLE TO SATISFACTORILY COMPLETE THE SFE'S AND WAS PLACED INTO CUSTODY FOR DUI. 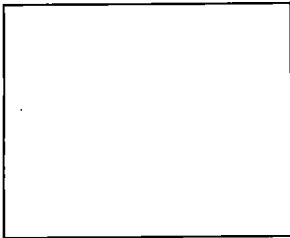
