The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 29 day of APRIL, 2020,

at approximately 2:17 PM, at 134 PINWOOD TERRACE, SAFETY HARBOR, 34695, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE (CARGILL, ROSWITHA), (WIFE) AND CO-HABITANT, AGAINST THE WILL OF (ROSWITHA CARGILL), TO WIT: (VICTIM STATED THAT AS THE HUSBAND ATTEMPTED TO RUN BACK OUTSIDE TO CONFRONT HER SON SHE ATTEMPTED TO HOLD THE DOOR SHUT. AS THE VICTIM HELD THE DOOR SHUT THE DEFENDANT GRABBED HER ARM AND STOMACH AND PUSHED HER OUT OF THE WAY).

(ROSWITHA STATED THAT SHE OBSERVED THE DEFENDANT ATTEMPTING TO RUN AFTER HER SON AND TRIED TO HOLD THE DOOR SHUT TO PREVENT HIM FROM GETTING OUT. ROSWITHA STATED AS SHE HELD THE DOOR SHUT THE DEFENDANT GRABBED HER ARM AND STOMACH AND PUSHED HER OUT OF THE WAY AND RAN OUT OF THE DOOR AFTER HER SON.) THE DEFENDANT ADVISED ME POST MIRANDA THAT HE DID PUSH ROSWITHA WHEN HE WAS TRYING TO GET OUT OF THE DOOR. A WITNESS ON SCENE ROSWITHA'S SON (MICHAEL HAYNES) STATED HE OBSERVED THE DEFENDANT PUSH ROSWITHA AS SHE ATTEMPTED TO KEEP HIM IN THE HOUSE.

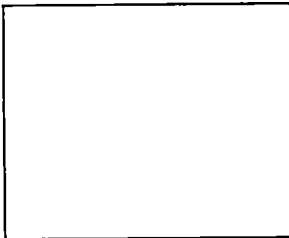
