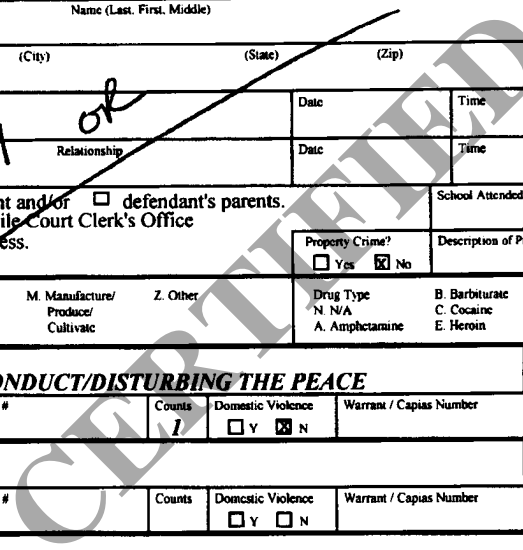



On Wednesday, March 18, 2020 at 0118 hours I was speaking with an individual in front of the Roxy's Restaurant located at 309 Clematis Street. The person was speaking with was in reference to her vehicle being possible stolen. I was in the process of dealing with this incident and an unknown white male walked over to my location. The white male was later identified as Richard Cook. It should be noted that his was St Patricks Day and there were many intoxicated people out on Clematis Street. This was also the state of emergency due to the Coronavirus Epidemic.

Cook interrupted our conversation. At first, I believed he had a true emergency and needed the police assistance. But he stated to me that he was a patron in Roxy's earlier in the night and had left and returned. As he attempted to enter the restaurant, he was refused entry. Cook then stated that the doorman "didn't think that I was cool enough!"

At this point I told Cook to stop interrupting my conversation with the woman about her stolen vehicle and asked him to stand on the sidewalk. He instantly became belligerent. He began to become verbal aggressive towards me and refused to listen to my lawful commands. I had escort Cook to the side walk. The entire time Cook in causing a disturbance.

I finished talking with the woman about her stolen vehicle and then walked over to Cook to have him stop causing a scene. Cook would not calm down and he was causing a breach of peach.

I made contact with Jamal Howard, the door man of Roxy's. He provided a verbal statement. He stated that Cook became belligerent when he was not allowed to enter the restaurant. Howard had to repeatedly ask Cook to leave and not cause as scene. Howard stated that the female bartenders were visibly upset with Cook's actions.



