D.U.I. PROBABLE CAUSE AFFIDAVIT

PERSONAL CONTACT

DRIVING PATTERN: ACTUAL PHYSICAL CONTROL (PHYSICAL EVIDENCE OR STATEMENTS PUTTING DEF. BEHIND WHEEL OF VEHICLE)

On 10/24/2020, at approximately 0135 hours, this Officer was conducting a traffic enforcement selective, in the area of 13500 block of ALT A1A, PBG, FL, when a vehicle was observed traveling at an increased rate of speed South bound in the outside through lane. Body worn camera and in car video were activated upon traffic stop. This Officer's initial visual estimate of the vehicle was approximately 70 MPH, in a posted 50 MPH zone. Using RADAR Stalker DSR2X (DB001317), rear antenna (KC086606), this Officer received a steady tone and reading of 67 MPH. The RADAR calibration was last checked on 06/17/2020 and was due on 12/17/2020. Prior to this tour of duty on this date, this Officer ensured the RADAR was in working order, to confirm the accuracy of the unit. At the end of this tour of duty, this Officer did the same. This Officer received RADAR/LIDAR certification on 05/31/2008, in Cannon AFB, NM. This Officer entered traffic behind the vehicle, a Chevrolet pick-up truck (JJ5AT/FL) and observed the vehicle slow for then disobey a steady red light at the intersection of Alt A1A and Florida Blvd. It should be noted, this intersection is not in PBGPD jurisdiction, thus the driver was not cited for the red light violation, this Officer simply made note of the infraction. This Officer initiated a traffic stop on the vehicle, in the area of Alt A1A ramp for southbound Interstate 95, PBG, FL. This Officer made contact with the driver, identified via Florida Driver License photo, Richard Hanna, while he was still in actual physical control of the vehicle.

OBSERVATION OF DRIVER:

Hanna had bloodshot, watery eyes, flushed red face, slurred speech and the obvious odor of an unknown alcoholic beverage emanating from his breath at conversational distance. This Officer was also able to detect the odor of burnt Cannabis emanating from the vehicle.

DRIVER'S STATEMENTS:

Hanna said he was coming from a buddy's house and denied consuming alcohol and/or THC or Cannabis on this evening.

Unknown alcoholic beverage. Burnt Cannabis

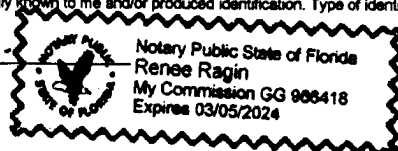

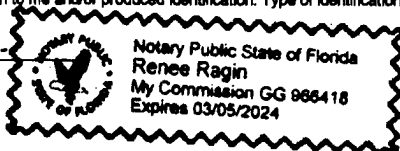


