The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law. On the 9 day of February, 2021 at 16:47 (Specifically include facts constituting cause for arrest.)

The following incident occurred in the City of Delray Beach, Palm Beach County, Florida. On 02/09/21, I was dispatched to 64 S Ocean Blvd (Sandbar) in reference to a white male (later identified as Richard Fantasia) causing a disturbance inside the establishment and refusing to leave. Upon arrival, I was greeted by three customers stating that a subject matching Fantasia's description was causing a disturbance inside of the business and was making them feel uncomfortable. Complainant/Sandbar's manager, Robert Paquette, escorting me inside the business and pointed out Fantasia to me. I walked up to Fantasia and observed him arguing with an unknown white male customer. Fantasia appeared to be intoxicated. I told Fantasia that he needed to leave. Fantasia continued to argue with the customer and I grabbed Fantasia by the arm to escort him out. While trying to escort Fantasia out, Fantasia tried to argue with another unknown female patron at the bar even though I was telling him to leave. I grabbed Fantasia by the shirt and escorted him out of the business and began talking to him about the issue inside. It should be noted that while escorting Fantasia out of Sandbar, numerous patrons cheered that he was being escorted out. Fantasia handed me his Florida Driver License and then began to yell at someone that was at the door of the business and started to go towards his direction in an aggressive manner. In fear that Fantasia was trying to possibly start something with the subject, I grabbed Fantasia and pushed him away. Fantasia became irate and was informed to place his hands behind his back. Fantasia refused to place and tightened his arms not allowing officers to handcuff him. After several verbal commands and me placing my taser on Fantasia's back, he complied and was handcuffed. While escorting Fantasia to the back of my vehicle, Ofc Huyett tried to readjust Fantasia's handcuffs and take Fantasia wallet out of Fantasia's hand, when Fantasia grabbed Ofc Huyett's fingers and would not let go. Ofc Huyett got a Sworn Statement on his BWC from Robert Paquette. Robert Paquette confirmed that due to Fantasia's actions inside the business it was causing a


