The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was operating a white 2008 Ford F-250 pick up truck, Florida tag LTZQ21. The defendant was observed by a concerned citizen (witness #1) driving in a manner in which he was swerving across the travel lane, crossing over the center painted lane marker, and drove off the roadway on three occasions. The witness contacted law enforcement. TPD CPL T. Sims (46180) located the vehicle in motion, and observed it weaving and crossing over painted lane markers. A traffic stop was conducted in order to check on the drivers condition and determine if he were sick, tired, distracted, or impaired. CPL Sims noted signs of impairment and requested a DUI Investigator to respond to the traffic stop to evaluate the defendant for impairment. I responded to the scene in this capacity. The defendant was observed standing near his vehicle, and was swaying noticeably. The defendant had a distinct odor of an alcoholic beverage on his breath, his face was flushed, and his eyes were bloodshot, glassy, and watery. The defendant wore a green and white paper bar admissions band on his right wrist which indicated that he was of 21 years of age. The defendant denied drinking any alcoholic beverages tonight. The defendant's perception of time was distorted, providing a time that was actually 3 hours slower than the real time. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant refused to submit to a lawful test of his breath for the purpose of determining its alcohol content after being read the Implied Consent Warnings.
