The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did knowingly and unlawfully commit the offense of Simple Battery (Domestic Violence), to wit:							
The defendant and victim are boyfriend/girlfriend of one year and currently reside together as "family members. Following a verbal argument, the defendant first pushed the victim in the forehead with his fingers, causing discomfort to the victim. A physical altercation ensued after the defendant "slammed" a door in the victims face which struck her. During the physical altercation, the defendant either "pushed or slammed" the victim on the ground, causing her to strike her head and lose consciousness. The victim suffered scrapes on her right shoulder and an open wound/bleeding on the back of her head. The victim left the scene and contacted law enforcement after arriving at a safe location. The defendant refused to provide a statement and did also have injuries to his left eyebrow and left cheek.
