The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above listed date and time, at the above listed location, Deputy Fisher ABN 252313 made contact with the defendant while conducting a traffic crash investigation (HCSO: 21-300397, DHSMV: 87711220), where the defendant caused the crash with approximately \$4,000 in property damage. The victim identified the defendant, as the person operating the vehicle at the time of the crash. Upon contact with the defendant indicators of impairment were observed to include bloodshot, watery eyes, slurred speech, and the odor of an alcoholic beverage on his breath. The defendant refused the opportunity to perform Standardized Field Sobriety Exercises after being explained the consequences. The defendant refused to provide a lawful breath sample after Implied Consent warning was read and understood. I queried the defendant through DAVID and learned he had a prior Suspension for refusal to submit to lawful test of breath, urine, blood on 6/20/13. The defendant was identified by his Florida driver license.
