### PERSONAL CONTACT

**DRIVING PATTERN:** (Actual Physical Control; Physical Evidence or Statements Putting Defendant Behind Wheel of Vehicle)

While traveling northbound I observed a blue Mazda CX-5 (bearing Florida license plate Z42HLQ) traveling southbound on N Military Trail without any lights on. I made a U-turn and caught up to the vehicle at N Military Trail and Gardenia Drive and the lights were still off. I initiated a traffic stop on the vehicle, with it slowing down and coming to final rest on Brady Lane. identified via his Florida Driver's License as Richard Baldwin Jr

### OBSERVATION OF DRIVER:

Odor of alcohol coming from vehicle and breath. Unsteady on his feet, swaying, difficulty maintaining balance. Glassy, faintly bloodshot eyes. Slurred and mumbled speech.



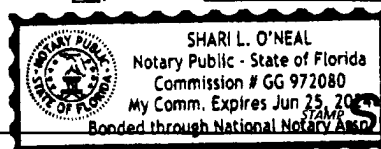

#### Walk and Turn

During the instructional phase, Baldwin was unable to keep balance, swaying and stepping out. Baldwin stated he would have difficulty performing this task, because of an issue with his knee. I questioned Baldwin on his knee issue and why he didn't tell me when I asked him before, where he denied having any issues. He stated, "I don't like mentioning it." I asked Baldwin if he would be able to perform this exercise, he stated, "I'll give it a try." I continued with instructions and demonstrated them to Baldwin. After instructions were given and Baldwin stating he understood, Baldwin started on command and I observed the following clues: Baldwin walked off the line. Baldwin stopped during the task to regain balance and raised his arms multiple times. He stopped and announced his ninth step. I told Baldwin to continue, at which point he did not turn as instructed. On the return, Baldwin stopped during the task to regain balance and again raised his arms more than six inches during the task. During this task, I also observed Baldwin look forward, not at his feet as instructed. Baldwin did not count aloud as instructed.

#### One Leg Stand

Upon the command to begin I observed the following clues: Baldwin swayed while balancing. Baldwin raised his arms more than six inches to maintain balance. Baldwin hopped to keep his balance and he put his foot down. He stopped himself and stated he was going to try again. I permitted Baldwin to restart, which I observed him sway, put his foot down and raise his arms. Baldwin decided to not attempt again.

#### Rhomberg

Upon the command to begin I observed Baldwin had a visible sway. Baldwin recited as instructed.

##### Modified Rhomberg

Baldwin lowered his head and had a visible sway. Baldwin overestimated the passage of thirty (30) seconds by 6 seconds. I noticed Baldwin had eye flutters when completing the exercise.

#### Finger to Nose

Baldwin had a visible sway. On the first left, Baldwin used the side of his finger and touched the side of his nose; on the first right, used the pad of his finger and smashed the tip of his nose; on the second left, used the pad of his finger and smashed the tip of his nose; on the second right, used the pad of his finger and smashed the tip of his nose; on the third right, used the pad of his finger and touched the tip of his nose and on the third left, used the pad of his finger and touched the tip of his nose.

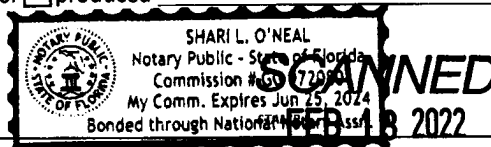

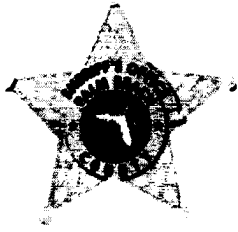

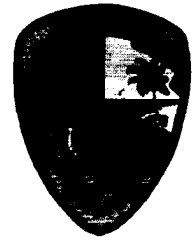
