I arrived at approximately 1759 hours.</p> <p>As I arrived, I was informed that Officer Crowley's investigation revealed that a white BMW sedan (FL - ISIP91) was traveling northbound on N Military Trl and failed to yield while making a left turn to travel westbound on W Yamato Rd in front of a black Ferrari (FL - NMMK86) that was traveling southbound on N Military Trl. The front of the Ferrari struck the passenger side of the BMW as the vehicles were traveling through the intersection.</p> <p>CSO McGovern (ID A625) witnessed a W/M, later identified via FL DL as Richard Ruderman, exit the white BMW immediately following the crash. Ruderman was the sole occupant of the white BMW. According to CSO McGovern, Ruderman exited the vehicle wearing only one shoe, had difficulty locating his keys despite them being in his hand, and displayed several other signs of impairment during their encounter. BRFR responded to the scene and assessed Ruderman for injuries. According to BRFR, Ruderman did not have any obvious injuries or medical need.</p> <p>I then walked towards Ruderman and, before I was even given a chance to introduce myself, Ruderman stated, "You should just hang me". While speaking with Ruderman, I observed that his speech was slurred, and his pupils were constricted. I also noticed that Ruderman had difficulty concentrating on one thing, rambled on about random subjects, and made spontaneous utterances such as "I'm guilty".</p> <p>When asked to explain the crash, Ruderman pointed towards N Military Trl and claimed it was Palmetto Park Rd. It should be noted that Palmetto Park Rd runs east/west and N Military Trl runs north/south. Palmetto Park Rd also never intersects with W Yamato Rd</p>

<p>which is an east/west roadway.</p> <p>Based on my observations, I suspected that, at the time of the crash, Ruderman may have been operating a vehicle within the state while impaired by alcohol and/or chemical or controlled substances. Ruderman was then informed that Officer Crowley's crash investigation was over and that I was conducting a criminal DUI investigation. I then asked Ruderman to submit to Standardized Field Sobriety Exercises. Ruderman agreed to participate.</p> <p>Initially, Ruderman stated he was not sick or injured. He then complained of back pain as well as leg pain. According to Ruderman, the pain did not affect his ability to walk, stand, or balance. Ruderman stated he was not diabetic or epileptic and did not have anything wrong with his eyes that isn't corrected by glasses or contacts. I then continued with the exercises.</p> <p>The first exercise was Horizontal Gaze Nystagmus. I administered the instructions and Ruderman stated that he understood. I first ensured that Ruderman's eyes had equal pupil sizes and tracked equally. I then continued with the exercise. Ruderman displayed lack of smooth pursuit and distinct and sustained nystagmus at maximum deviation in both eyes. It took several attempts to complete this exercise due to Ruderman's poor balance and complaints of leg and back pain. Ruderman also had to be reminded to not move his head several times during the exercise. Lastly, I observed that, at times, Ruderman stopped looking at the stimulus with his eyes.</p> <p>Ruderman continued to complain of leg and back pain following this exercise, however, he claimed that it did not affect his ability to walk, stand, or balance. I asked Ruderman if he wanted to continue with the Standardized Field Sobriety Exercises, and he stated that he did. Despite Ruderman's willingness to participate in the exercises, I ultimately determined that the Walk-and-Turn and the One-Leg Stand were both unsafe and impractical due to Ruderman's apparent impairment and inability to stay on his feet. For this reason, I bypassed the exercises and moved on to an exercise which is less physically demanding.</p> <p>The second exercise was the Finger to Nose. Ruderman was asked to sit on the curb for his safety and to alleviate some of his leg and back pain. I confirmed that Ruderman knew his left from his right by asking him to show me his left hand and then his right hand. I then administered the instructions and Ruderman stated he understood. The predetermined sequence was L-R-L-R-R-L. When instructed "Left", Ruderman was unsure of what to do. I then administered the instructions a second time to ensure that Ruderman knew what to do. Ruderman's inability to concentrate and comprehend the instructions did not allow me to conduct the exercise. At this time, I determined it was impractical to continue with the Standardized Field Sobriety Exercises.</p>

	<p>Based on my investigation, and the totality of the circumstances, I found probable cause to believe that, at the time of the crash, Ruderman was operating a vehicle within the state while impaired by alcohol and/or chemical or controlled substances. Ruderman was placed under arrest for DUI per F.S.S 316.193(3c1).</p> <p>Ruderman was transported to BRPD booking for post arrest processing and the administration of a breath test. Officer Ricciardi (ID817) (Breath Test Operator) responded to BRPD booking and assisted with the BAT room procedures. Ruderman was asked to provide a sample of his breath for the purpose of determining the alcohol content. Ruderman provided two samples of .000 and .000. I then asked Ruderman to provide a urine sample for the purpose of detecting the presence of chemical or controlled substances. Ruderman stated he would submit. I informed Ruderman of Implied Consent at this time should he change his mind after exiting the breath testing room. We then exited the room and I attempted to collect a urine sample from Ruderman. After some time, Ruderman stated he was unable to urinate at the very moment. We then returned to the room and continued with the BAT room procedures. I informed Ruderman of his constitutional warnings (Miranda) and he advised he understood. Ruderman refused to answer any further questions. See DUI influence report for further.</p> <p>Several attempts to collect a urine sample from Ruderman at different times all yielded negative results. At 2013 hours, Ruderman's inability and/or uncooperativeness was deemed a refusal to submit to a urine test. Ruderman was later transported to BRRH for medical clearance and was given a final chance to provide a urine sample at 2135 hours. I observed that Ruderman had difficulty urinating and informed him that his inability/uncooperativeness to provide a urine sample would continue to be a refusal to submit to a urine test. Ruderman then stated "Alright, forget it then". No additional attempts to collect a urine sample were made.</p> <p>Ruderman was later transported to Palm Beach County Jail and turned over to Palm Beach County Jail.</p>
