On Thursday, May 14th, 2020, at approximately 1402 hours I responded to [REDACTED], FL [REDACTED] in reference to what was dispatched as a Domestic Disturbance. According to notes provided to me by PBSO dispatch, the caller, later identified as Morgan Mackey, had called 911 and reported her mother, Sandra Mackey, and her step-father, Richard Spindler, had gotten into a physical altercation. Morgan told the dispatcher Richard was trying to push her mother down the stairs of the home. I was further updated that Richard had separated from Morgan and Sandra, and was now taking a shower, while they were locked in another room.

Upon arrival, I made an approach to the home, and while doing so, I could see two females, later identified as Sandra and Morgan, moving around the downstairs living room, along with a young, toddler-aged child, I was able to make visual contact, and was met at the door by Sandra and Morgan. I asked where Richard was and they told me he was upstairs. I asked if he was still taking a shower and they said, "no". I learned Richard is married to Sandra, and has been for four years. They live in this home as a family, along with Morgan, who has recently moved in with them.

Richard was located in the upstairs, masterbedroom, which was locked. He did not answer when Sandra called out to him. She used her key to open the door, and Richard was behind the door. Once I had contact with Richard, I separated the two and asked them to tell me what had happened. Sandra told me she was in a verbal argument with Richard, over the fact he accused her of spying on him. He had been seeing a counselor and Sandra uncovered messages between Richard and counselor, which enraged Richard, as he thought his privacy had been violated. Sandra and Richard started to argue over pizza which Sandra had ordered. According to her, she asked if he wanted some and this devolved into him throwing pizza at her. I was able to observe smeared food all over the glass panels that line the bannister of the home's staircase.

Sandra said after Richard threw the pizza at her and then smeared it on the glass, she tried to get away from him, by walking up the final flight of stairs in the home. According to her, Richard leaped forwards, towards her and hit her, "up the stairs". She said she fell onto the stairs and Richard then began hitting her on her ankles and feet with a closed fist. When interviewed separately, Morgan told me she witnessed this event from the top of the staircase, and recalled seeing Richard jump at her mother, Sandra, knocking her to the stairs. Upon being on the ground, Richard stood over her and, with a closed fist, began striking her near her ankle. Sandra did have a red mark on her right ankle that did appear consisted with being struck.

When interviewing Richard, although he did deny being under the influence of alcohol, his eyes were bloodshot and glassy, an obvious odor of an unknown alcoholic beverage was emitting from his persons, and he swayed in a figure eight pattern, when he was not supporting himself on furniture. He told me he and Sandra had been arguing for some time over her stealing his private messages between his counselor and him. In turn, he entered Morgan's computer and went through her things, just to make Sandra feel as violated as he did. According to him, while seated on the couch downstairs, Sandra threw a piece of pizza at him, and he in turn, spit pizza at her. What he described did not match the food that was smeared into the glass of the stair's banister. I did not find any thrown or discarded food near where Richard said he was sitting. Richard denied that the argument ever reached a physical level. I did observe a scrape on Richard's left leg, above where his kneecap was. I questioned him about that, and he advised he likes to lay on the floor, reading food magazines, and cutting out the recipes to try out at a later time.

Based on my observations and interviews, Richard Spindler was arrested for one count of Domestic Battery, as he willfully and knowingly struck Sandra Mackey, his wife of four years, with a closed fist, after pushing her down on the stairs of their home, which is contrary to FSS 784.03(1).
