**D.U.I. PROBABLE CAUSE AFFIDAVIT**

ON THE 22nd DAY OF March 2021 AT 2123  A.M.  P.M.

**PERSONAL CONTACT/DRIVING PATTERN/OBSERVATION OF DRIVER:**

On March 22nd, 2021 at approximately 2123 hours, SGT. Hery (who was operating a marked BBPD patrol vehicle) conducted a traffic stop at the 100 block of West Woolbright RD on a Black Lexus Sedan bearing FLtag IE21NN for operating with an expired tag (as of 10/24/2020) and for tailgating (following another vehicle closely). The traffic infractions were observed while traveling south bound on I95 by Sgt Hery. The Lexus stopped at the 1400 block of SW 2nd ST and made contact with the driver W/M Richard Ray Jr (10/24/79).

I responded to the traffic stop and made contact with Ray at the driver side of his vehicle. Ray stated that he was coming from Taco Bell in the area of Jog and Hypoluxo and is now heading back to his residence at Hypoluxo RD and 441. Ray stated that the reason he was traveling southbound on I95 near Woolbright RD is because he is turning around to head back home. Let it be noted that Ray was traveling southbound on I95 which is in the opposite direction of his residence. While making contact with Ray, I noticed that he had glossy red eyes, slurred speech as he spoke, the odor of alcohol emanating from within his vehicle, appeared to be disoriented and confused. Ray was asked to step out of his vehicle. While outside of his vehicle Ray stated that he had consumed two cups of wine approximately an hour and a half ago. Ray stated at consuming his 2 glasses of wine he left his residence for a slurpee. While speaking with Ray, I smelled the odor of unknown alcoholic beverage emanating from his breath that intensified as he spoke.

Due to the above observations, I suspect Ray to be under the influence of alcohol while operating a motor vehicle. Ray agreed to SFST. Prior to starting the tasks Ray stated that he has no injuries or disabilities. Ray stated that he has previously performed the task and I instructed him to not begin the task until I tell him to start. After checking Ray's eyes he followed me to a yellow/gold tapped line on the ground that he was able to point out to me and identify as a line.

**HORIZONTAL GAZE NYSTAGMUS:**

- Left eye does not follow smoothly
- Left eye prior to 45 degrees
- Distinct jerking in left eye at maximum deviation
- Vertical Nystagmus in left eye

- Right eye does not follow smoothly
- Right eye prior to 45 degrees
- Distinct jerking in right eye at maximum deviation
- Vertical Nystagmus in right eye

**WALK AND TURN:**

This task was explained and demonstrated to Ray, which he stated he understood. While I was demonstrating and giving instructions, Ray stepped off the line and was unable to maintain his balance. While Ray was performing the task he stepped off the line completely, missed the line, used arms for balance and took the incorrect number of steps on his first 9 steps and his second 9 steps.

**ONE LEG STAND:**

This task was explained and demonstrated to Ray, which he stated he understood. While performing the task Ray used his arms for balance (was told to keep arms at his side several times), and put his foot down several times throughout this task.

**FINGER TO NOSE:**

This task was explained and demonstrated to Ray, which he stated he understood. While I was demonstrating and giving instructions, Ray had begun the task to soon and was uncooperative. When told to begin the task by tilting his head back and closing his eyes Ray had immediately raised his hand to his nose without me giving him directions like I instructed. Ray was once again informed the instructions. When performing the task Ray's left index finger tip touched his upper lip/ mustache area every time.

**ROMBERG/ALPHABET:**

This task was explained and demonstrated to Ray, which he stated he understood. Ray performed the task.

Ray was handcuffed (D/L) and taken into custody without incident. I then transported Ray to the Palm Beach county Breathalyzer at the Palm Beach County jail. Upon my arrival at 2226 hours, I completed the required 20-minute observation. I then requested Ray provide a sample of his/her breath for the purpose of determining the alcohol content. Ray refused my request, at which time I read him Implied Consent, which he stated he understood. A second request was made to Ray to provide a sample of his/her breath, which was again refused.


At this time, due to the above mentioned information I have established probable cause to charge Ray with one count of DUI pursuant to FSS 316.193(1). As well as refusal to submit to a lawful test of Breath Blood or Urine pursuant to FSS 316.193(1)(D)

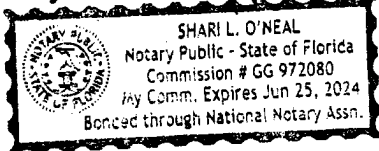


Upon completion of the booking process, Ray was turned over to Palm Beach County Jail.

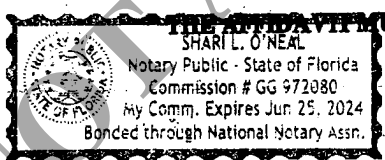
