The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 6/10/2021, at approximately 0229 hours, Affiant observed a grey Ford truck bearing FL tag LPIH90 (VIN:1FTYR10D33PA01768) stopped at a red light at the intersection of Manhattan Av N/Waters Av W. The lights controlling westbound traffic turned green, but the arrow controlling traffic traveling southbound from Waters Av W remained red, however Affiant observed the silver Ford conducting a left turn to begin traveling southbound. Affiant conducted a traffic stop on the vehicle at Manhattan Av N / Bird St W in Tampa, FL and observed the defendant operating the vehicle and to be the sole occupant. Affiant immediately detected the distinct odor of an alcoholic beverage emanating from the defendant's breath, his eyes were bloodshot and glassy; and he exhibited fumbling fingers when retrieving requested vehicle documentation. Affiant requested the defendant perform Standard Field Sobriety Exercises (SFSEs) which the defendant agreed to do. During the SFSEs, the defendant showed multiple signs of impairment and was subsequently arrested for driving under the influence (DUI). Deputy S. Thorne ABN 234165, who is a certified Breath Technician, was on scene in his unmarked HCSO vehicle which is equipped with an intoxilyzer. The defendant refused to provide a sample of his breath to determine his breath alcohol content (BrAC). Affiant read Implied Consent to the defendant, he understood and replied "No." The defendant was identified via FL DL. The defendant was given a DUI citation AA2SO5E. The defendant also received Uniform Traffic Citation A95JIOE, for Failing To Stop At A Steady Red Light.
