The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did

Beginning on 10/02/2020, I was working in an undercover capacity on a social media application while attempting to locate and identify individuals who were using these applications for the exploitation of children. I was utilizing an investigative persona which identified herself as a fifteen year old female and began a conversation with the Defendant who was immediately provided with my covert cellular telephone number and then subsequently provided with my fictitious age. The Defendant made the initial contact with the fifteen year old investigative persona on the application and also made the initial contact via text message communication utilizing phone number 812-229-7878, which was registered to the Defendant through the cellular service provider Sprint. During the course of the conversation, the Defendant unlawfully sent explicit and harmful data detailing the actions the Defendant would take towards the fifteen year old female investigative persona and solicited the fifteen year old investigative persona for sexual acts. On 10/02/2020, the Defendant stated the following to my fifteen year old investigative persona: "He wants you to submit to him when he's massaging you", "And I'll slide those shorts off you", "I'll bend you over and slide those panties to the side and taste you up and down", "And then im gonna penetrate you hoelwever I desire...however". The Defendant was identified via his DAVID photograph and the digital photographs the Defendant sent to the fifteen year old investigative persona. The Defendant utilized his personal cellular telephone during the commission of this offense. The Defendant travelled to a predetermined meet location to make contact with the fifteen year old investigative persona. Upon the Defendant's arrival to the predetermined meet location, he was taken into custody. A controlled telephone call was placed to 812-229-7878 (the telephone number used by the defendant during the communication) and the HCSO covert phone number utilized by the fifteen year old investigative persona was displayed on the screen of the defendant's cell phone.
