Probable Cause

On July 3, 2021 at approximately 0114 I was monitoring northbound traffic on Interstate 95 north of Atlantic Avenue (State Road 9). I observed a Blue SUV bearing the license plate (North Carolina) HKA4901 traveling in the inside lane with no headlights traveling at a high rate of speed. I proceeded behind the vehicle and while pace clocking the vehicle the vehicle overtook several vehicles cutting in and out of traffic at 105 Miles Per Hour in a 65 Miles Per Hour zone. I activated my emergency equipment and conducted a traffic stop on the northbound exit ramp of Boynton Beach Boulevard.

I approached the passenger's side of the vehicle and observed Riley John Walter Grace later identified by Florida Driver's License # G620739752920. I introduced myself and explained the reason for the stop to Mr. Grace and requested his Driver's License, registration, and proof of insurance. The reason for the stop was for speed and driving without headlights. During the initial interaction, I observed a strong unknown alcoholic beverage emitting from inside the vehicle. I also observed glassy eyes, lethargic speech, and dry mouth from Mr. Grace. At the time of the stop Mr. Grace repeatedly advised that he was almost home. After providing me with the documents I issued Mr. Grace a citation for speed and driving without headlights. Based on the indicators of driving impaired, I requested that Mr. Grace step outside the vehicle. After the stepping out the vehicle, I asked Mr. Grace to perform voluntary Standard Field Sobriety Exercises and Mr. Grace agreed. Mr. Grace incoherently mumbled many things. While outside the vehicle I smelled an unknown alcoholic beverage coming off Mr. Grace. Before the exercises, I asked Mr. Grace if he had an physical injuries or any neurological problems I had to be aware of. Mr. Grace explained that he was uncoordinated and had back problems from a prior job.

Horizontal Gaze Nystagmus: I observed equal pupil size and equal tracking. I observed a lack of smooth pursuit in both eyes and distinct and sustained nystagmus at maximum deviation. I also observed an onset of nystagmus prior to 45 degrees with both eyes. After horizontal gaze nystagmus I checked or Vertical Gaze Nystagmus and did not observe nystagmus. During the exercise Mr. Grace had difficulty following the stimulus with his eyes only by moving his head. During the exercise Mr. Grace swayed back and forth. While looking for Vertical Gaze Nystagmus Mr. Grace complained about his position on the shoulder and requested to standing facing north instead of west on the interstate.

Walk and Turn: Before the exercise, Mr. Grace complained about his footwear, so I asked him if he wanted to take off his shoed. He advised yes. During the instruction phase, Mr. Grace was given verbal instruction to maintain the starting position while I demonstrated the exercise and immediately had difficulty maintaining his balance. Mr. Grace fell out of position several times during the instructional

phase. Mr. Grace missed all nine heel to toe steps and step off the line. Mr. Grace also executed an improper turn and took the incorrect number of steps back.

One Leg Stand: I explained and demonstrated the exercise to Mr. Grace. During the exercise Mr. Grace used his left foot and put his left foot down. Mr. Grace was unable to keep balance, hopped, and used his arms for balance.

Based on the totality of circumstances, there was probable cause to arrest Mr. Grace for Driving Under the Influence. I then placed Mr. Grace under arrest.

Mr. Grace was transported to Palm Beach County Jail and during the ride to the jail Mr. Grace was very talkative and apologetic. I arrived at the BAT at 2:00 AM. During the 20 Minute Observation perios Mr. Grace had to be told to sit down in the chair multiple times. Mr. Grace complained about the handcuffs being too tight and I provided him an extra pair of handcuffs and loosened the handcuffs. At the BAT Mr. Grace was very discourteous to the BAT technician and repeatedly failed to follow procedures and protocol. After the observation period, Mr. Grace was read implied consent and refused to provide breath to determine the alcohol content. I advised Mr. Grace of the consequences if he refused and Mr. Grace again refused to provide breath.

Mr. Grace was then booked in the Palm Beach County Jail
