at approximately 2:00 AM, at 14400 49TH ST N, in Pinellas County did:

UNLAWFULLY HAVE IN HER ACTUAL OR CONSTRUCTIVE POSSESSION, A SUBSTANCE DEFINED BY FLORIDA STATE STATUTE CHAPTER 893, TO WIT: ALPRAZOLAM .25MG, WITHOUT HAVING LAWFULLY OBTAINING SAID SUBSTANCE FROM A VALID PRACTITIONER. THE SUBSTANCE WEIGHED LESS THAN ONE GRAM.

A PRESUMPTIVE TEST WAS POSITIVE.

THE DEFENDANT WAS ARRESTED FOR DOMESTIC BATTERY AND TRANSPORTED TO THE JAIL BY G4S. I WAS NOTIFIED TO THE JAIL TO COLLECT A PILL WHICH WAS FOUND IN THE DEFENDANT'S WALLET. 1 WHITE ROUND PILL WITH THE IMPRINT "027 R" WAS FOUND BY DEPUTY MATT UPON SEARCHING THE WALLET IN INTAKE RECEIVING. THE PILL WAS IDENTIFIED VIA WWW.DRUGS.COM TO BE ALPRAZOLAM .25MG, A SCHEDULE 4 CONTROLLED SUBSTANCE. THE DEFENDANT WAS ASKED IF SHE HAD ANY DRUGS OR WEAPONS IN HER POSSESSION PRIOR TO ENTERING THE TRANSPORT VAN.

WHEN ADVISING THE DEFENDANT AN ADDITIONAL CHARGE WAS BEING ADDED, SHE ADVISED THE PILL WAS GIVEN TO HER BY HER MOTHER.

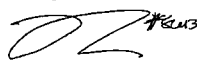

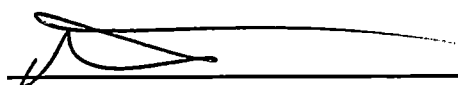
ADVISORY AND SOLVENCY HEARING

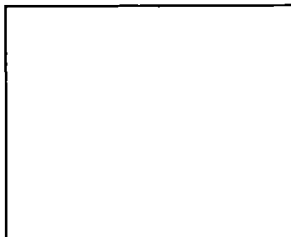
