The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was observed by the witness, (an off duty law enforcement officer) driving a pickup truck northbound on Sandy Pointe Dr. The truck stopped behind a U-Haul truck that was unloading its contents with the ramp down from the back of the truck to the ground. The vehicle stayed behind the U-Haul for an extended period of time, as if not realizing the vehicle was not being operated. The truck then attempted to pass the U-Haul, however drove up the ramp before realizing its mistake. The vehicle then reversed, nearly striking a mailbox and a tree. The witness made contact with the defendant and for safety purposes removed him from the vehicle. The defendant exhibited indicators of impairment to include a flushed face, droopy eyes, glassy eyes, the odor of an alcoholic beverage emanating from his breath, unsteadiness on his feet and very slurred speech. The defendant refused to participate in SFSE's after being advised a decision would have to be made without his participation. The defendant was placed under arrest for DUI. The defendant refused to provide a breath sample after being read Implied Consent. The defendant has 2 prior refusals per DAVID.

The defendant was ID'ed via FL DL.
