The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 12/04/2020, at approximately 1811 hours, Deputy M. Taber (ABN 256562) and Deputy D. Randall (ABN 244931) responded to the intersection of Gunn Hwy and Birmingham St, in reference to a traffic crash involving a gray Nissan Frontier (FL tag: KUAX37) and a white Toyota Camry (FL tag: DWH594). The traffic crash was investigated by Deputy Randall under HCSO case #20-783462 (DHSMV #89442173). Deputy Taber observed the defendant inside the vehicle. The defendant was operating his Nissan Frontier when he struck the rear of the Toyota Camry. As a result, the vehicles sustained approximately \$8,000.00 in damages. Upon contact with the defendant, he had slurred speech, bloodshot glassy eyes and the distinct odor of an alcoholic beverage emitted from his breath as he spoke. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he initially agreed. After the HGN exercise, the defendant refused to continue. Based on the totality, the defendant was placed under arrest for DUI with property damage. Implied consent was read and the defendant refused to provide a lawful sample of his breath. A query of the defendant revealed he has a prior refusal to submit to any DUI test on 06/01/2005. The defendant was positively identified via his Florida driver's license.
