The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: During the course of a crash investigation where the listed defendant struck a vehicle from behind at a red light hard enough to push it into the stopped vehicle in front of it, the defendant, who is a licensed driver in the State of Florida, was suspected to be under the influence of an alcoholic beverage. The defendant smelled strongly of an alcohol beverage, had glassy eyes and while spoke clearly, was nonsensical and random in the statements he was making. Upon my arrival, called to the scene because of the suspicion of alcohol, I asked the defendant if he'd been drinking, he stated that he could not due to cirrhosis of the liver and that his doctor told him that he can't drink. He further stated that he's on a list for a liver transplant. After telling him that he was suspected of being intoxicated, the defendant then submitted to the Standardized Field Sobriety Exercises and failed to complete them satisfactorily. Upon transporting him to Central Breath Testing, I read him Miranda and asked him why he would have failed the exercises. He stated that he'd smoked marijuana and that his girlfriend made him a mixed drink last night. Once at CBT, the defendant refused to submit to a breath test. He was then brought to Booking for processing. The defendant was positively identified by FL DL.
