

DRIVING PATTERN: Actual physical control (physical evidence or statements putting def. behind wheel of vehicle)

On Thursday April 22, 2021 at approximately 1923 hours I was dispatched to a minor single vehicle crash with a suspected impaired driver. Upon arrival I met with D/S E. Guarin #36182 who provided me with a written sworn supplemental probable cause affidavit stating the following: "On April 22, 2021 at approximately 1914 hours I was notified by a relative that a vehicle in my neighborhood lost control and appeared to have crashed. They then observed an older male sitting behind the wheel in physical control of the vehicle. The subject appeared confused and disoriented. I then arrived on scene within 30 seconds due to living in the area. I then observed an older male sitting in a Silver Nissan bearing FL tag "GJCE89". The male then got out of the vehicle and advised me that he was disabled on the roadway. The subject was unsteady on his feet and was slow and delayed in his speech, his eyes were glassy and he appeared confused. He was swaying back and forth while standing still. He was identified as Robert Jeffreys also the registered owner of the vehicle. I asked him where he originally crashed. Jeffreys advised me that he crashed on "38th". It should be known that there are obvious skid marks on the roadway and matching damage to his vehicle. His zipper on his pants were down and he appeared confused and dazed. He additionally advised me that he was the sole occupant of his vehicle."

OBSERVATION OF DRIVER:

I observed the above described defendant to still be occupying the front driver seat of the vehicle. I spoke to him briefly in the car and noticed his eyes to be glassy and his speech to be slow, slurred, and deliberate. I asked the defendant to exit his vehicle and walk to mine. The defendant was unsteady on his feet and weaved towards the open travel lane as he walked to my car. I noticed his zipper was down on his blue jeans and a button on his shirt near his stomach was also undone. The defendant had a noticeable orbital sway as he stood. I asked the defendant to stand in front of my car. The defendant leaned on my hood and bumper as we spoke.

DRIVER'S STATEMENTS:

Pre Miranda the defendant stated he was coming from home to go to Publix when his vehicle struck a curb. The defendant stated he struck a curb on his driver side yesterday and his car had a spare tire on it. Post Miranda the defendant stated that he was not diabetic or epileptic. The defendant stated he was not injured and had no physical defects. The defendant stated he takes prescription medication for blood pressure. The defendant admitted to consuming vodka on ice around noon.

ODORS:

I immediately detected the odor of an unknown alcoholic beverage coming from the defendant's breath, which intensified when the defendant spoke.

The defendant used his arms for balance and swayed during this task.

FINGER TO NOSE:

The defendant was placed into the instructional stance for the Finger to Nose task and given instructions. The defendant had a noticeable orbital sway during this task. The defendant searched for his nose with his finger. The defendant touched his cheek, under his nose, and on the bridge. The defendant did not touch tip to tip as instructed and demonstrated on any attempt.

ROMBERG ALPHABET:

The defendant was placed into the instructional stance for the Romberg Alphabet task and given instructions. The defendant had a noticeable orbital sway during this task. The defendant had to be reminded to keep his eyes closed. 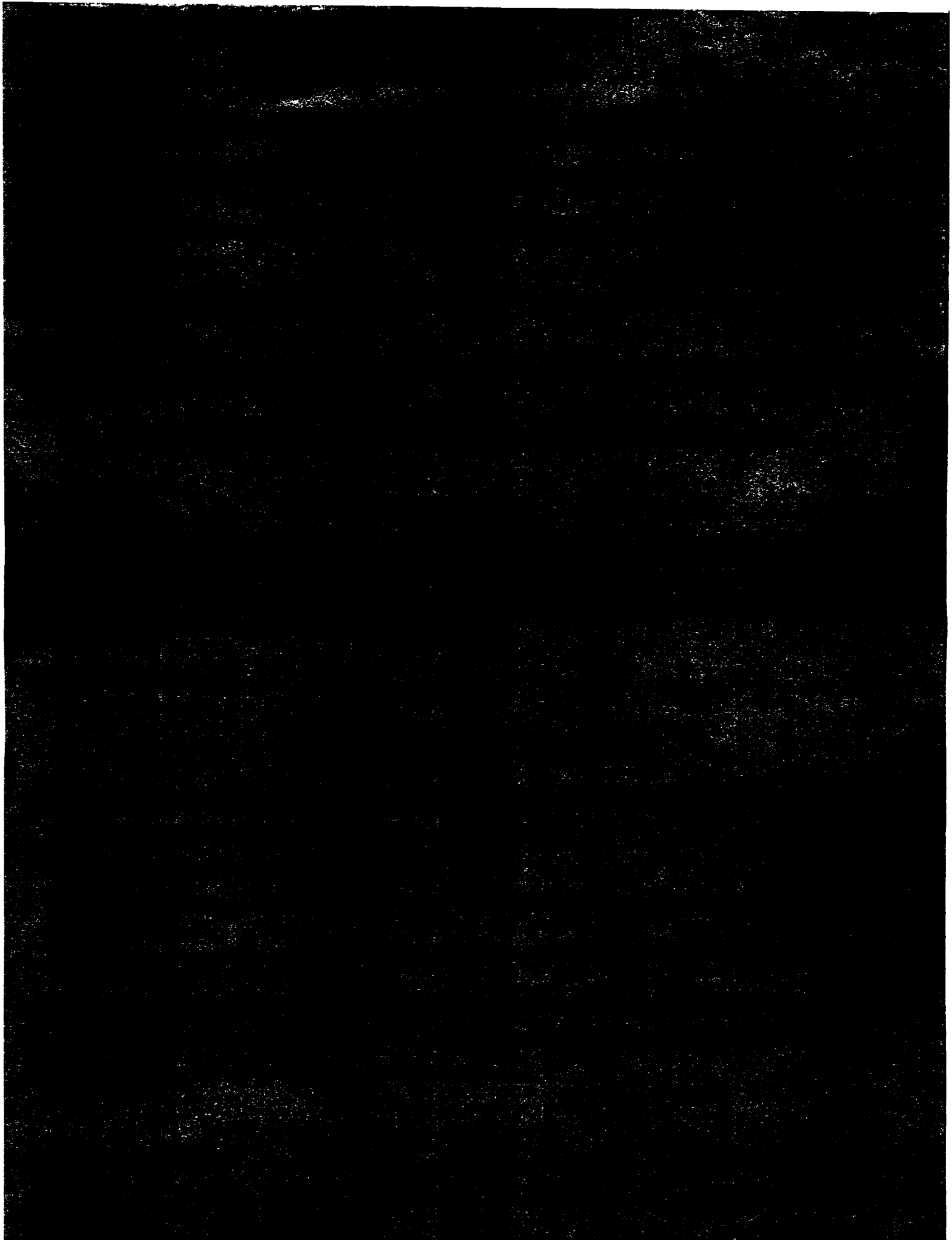
